Resolution 2019 – 08

(Enacted on June 11, 2019)

A RESOLUTION TO APPROVE A RENEWED POLICE SERVICES AGREEMENT WITH THE INGHAM COUNTY SHERIFF'S DEPARTMENT COVERING THE PERIOD OF JANUARY 1, 2020 THROUGH DECEMBER 31, 2023.

WHEREAS, the Village of Webberville and the Ingham County Sheriff's Office wish to renew an agreement for law enforcement services; and

WHEREAS, the Village of Webberville, Ingham County Controller and the Ingham County Sheriff have negotiated an agreement which covers a four year period, beginning January 1, 2020 and ending December 31, 2023; and

WHEREAS, the Village of Webberville has contracted with Ingham County for police services through the Sheriff's Office since 1994; and

WHEREAS, the Village of Webberville wishes to continue their 80 hours of guaranteed service per week for the upcoming fiscal years (see the attached agreement).

THEREFORE BE IT RESOLVED, the Village of Webberville approves a four year contract with the Ingham County Sheriff's Office for a period covering January 1, 2020 through December 31, 2023 for the sum of:

- 1/1/2020 – 12/31/2020 \$330,555
- 1/1/2021 – 12/31/2021 \$309,135
- 1/1/2022– 12/31/2022 \$317,948
- 1/1/2023 – 12/31/2023 \$327,043


Total 4 year cost \$1,284,681

BE IT FURTHER RESOLVED, the Village of Webberville authorizes the Treasurer to make any necessary budget adjustments in the Village of Webberville 2020-2023 budgets to make the quarterly payments.

BE IT FURTHER RESOLVED, THE Village of Webberville authorizes the Village President and the Village Clerk/Treasurer to sign all necessary documents consistent with this resolution.
