Council Trustee Deborah Walter addressed the Village President, Brad Hitchcock, and President Pro Tem, Sam Schulte, regarding council attendance and gender bias. Ms. Walter brought the council to a point of order regarding these topics. Ms. Walter wanted to know if the rules are different for the Men than it is for the women when it comes to attendance. She was wondering why Mr. Schulte, President Pro Tem, was allowed to be absent six times when she was told by him, when appointed to council, that she could not miss more than three times or she would be removed from council. Ms. Walter stated that according to what was said, and our Village by laws, Mr. Schulte should be removed for his absences. Mr. Schulte denied that he told that to her, and stated that they were excused absences, and that you are removed only after three unexcused absences.

RE: ICSO / Village of Webberville Law Enforcement Services Agreement

Per our conversation, the Village of Webberville would like to revert to eighty (80) hours per week of law enforcement coverage beginning January 1, 2024. Our current, amended agreement, is to expire on December 31, 2023.

Below are financials related to the Ingham County Sheriff's Office continuing to provide law enforcement services to the Village of Webberville for calendar years 2024 and 2025, with an option to extend the agreement an additional one-year period, through December 31, 2026.

2024: \$343,395.00 (5% increase from the original 80 hours per week agreement for 2023)

2025: \$360,565.00 (5% increase from 2024)

2026: \$378,593.00 (5% increase from 2025)

All other terms and conditions of the existing agreement, with the exception of the hours per week (increase from 40 hours to 80 hours) would remain unchanged.

Let me know when you have had a chance to review the proposal. If acceptable I will proceed with preparing a Resolution and drafting a new agreement.

Attached is the Agreement for Law Enforcement Services to be entered into between the Sheriff, County and the Village of Webberville. The term of the attached Agreement covers a period of January 1, 2024 through December 31, 2025, with an option to extend an additional one year. The compensation which the Village shall pay to the County for the law enforcement services to be provided by the Sheriff's Office includes:

- A. \$343,395.00 to be paid in calendar year 2024;
- B. \$360,565.00 to be paid in calendar year 2025; and
- C. \$378,593.00 to be paid in calendar year 2026.

The County Board of Commissioners authorized the attached Agreement in **Resolution No. 23-515**. A copy of this Resolution has also been attached.

If the attached Agreement is satisfactory, you may after printing off copies thereof proceed to obtain the signatures necessary for their execution. **RESOLUTION TO APPROVE A LAW ENFORCEMENT SERVICES AGREEMENT
WITH THE VILLAGE OF WEBBERVILLE COVERING THE PERIOD OF JANUARY
1, 2024 THROUGH DECEMBER 31, 2026**

RESOLUTION #23 – 515

WHEREAS, the Ingham County Sheriff's Office and the Village of Webberville wish to extend and expand the current agreement for law enforcement services; and

WHEREAS, the Village of Webberville, Sheriff's Office and the Controller's Office have negotiated the financials of an agreement that covers a two-year period, beginning January 1, 2024 through December 31, 2025, with an option to extend the agreement an additional one-year period through December 31, 2026; and

WHEREAS, the Village of Webberville has contracted with Ingham County for law enforcement services through the Sheriff's Office since 1994; and

WHEREAS, the Village of Webberville wishes to increase from 40 hours per week to 80 hours per week of law enforcement service coverage for the upcoming fiscal years.

THEREFORE BE IT RESOLVED, that the Ingham County Board of Commissioners approves a two-year agreement, with an option to extend an additional one-year period, the law enforcement services agreement with the Village of Webberville for the period covering January 1, 2024 through December 31, 2026 for the sum of:

• January 1, 2024 – December 31, 2024	\$343,395
• January 1, 2025 – December 31, 2025	\$360,565
Two-year total:	\$703,960
• January 1, 2026 – December 31, 2026	\$378,593
Three-year total:	\$1,082,533

BE IT FURTHER RESOLVED, that the Ingham County Board of Commissioners authorizes the Controller/Administrator to make any necessary budget adjustments in the Ingham County Sheriff's Office 2024-2026 Budgets.

BE IT FURTHER RESOLVED, that the Ingham County Board of Commissioners authorizes the Board Chairperson and the Sheriff to sign all necessary contract documents consistent with this resolution upon review and approval as to form by the County Attorney.

AGREEMENT FOR LAW ENFORCEMENT SERVICES

THIS AGREEMENT, effective January 1, 2024, is made and entered into by and between the **SHERIFF OF INGHAM COUNTY, SCOTT A. WRIGGELSWORTH**, (hereinafter referred to as the "Sheriff"), the **COUNTY OF INGHAM** (hereinafter referred to as the "County"), and the **VILLAGE OF WEBBERVILLE** (hereinafter referred to as the "Village").

WITNESSETH:

WHEREAS, the Village desires to secure certain law enforcement services from the Sheriff; and

WHEREAS, the County and the Sheriff agree that the Sheriff shall provide the Village with those law enforcement services as outlined below and as permitted by law.

NOW, THEREFORE, for and in consideration of the mutual covenants hereinafter contained, **IT IS HEREBY AGREED**, as follows:

I. **Agreement Period and Termination.** This Agreement shall commence on the 1st day of January, 2024, and unless prematurely terminated by either party as authorized in this Agreement shall continue through the 31st day of December, 2025, with an option to extend the Agreement for one (1) additional year. If the extension option is mutually agreed upon by the Sheriff and the Village, the term of this Agreement shall be extended to December 31, 2026, at which time this Agreement shall terminate.

Notwithstanding any other provisions in this Agreement to the contrary, either the County or the Village may, with or without cause, terminate this Agreement at any time upon one hundred eighty (180) days prior written notice to the other party. In the event this Agreement is prematurely terminated, the Village shall pay the County, as set forth in Section IX, the total sum due for services performed by the Deputy Sheriffs assigned to the Village up to the effective date of termination.

In the event this Agreement is terminated and the Village creates its own police department, it is expressly understood and agreed by the parties hereto that the Village shall give preferential consideration to the hiring of any Deputy Sheriffs which had been assigned to the Village under this Agreement who are discharged as a result of the termination of this Agreement.

II. **Services to be Provided by the Sheriff.** The Sheriff shall provide the Village with general law enforcement services including, but not limited to, the enforcement of Village's ordinances. These law enforcement services shall be performed in accordance with the following schedule:

- A. Eighty (80) hours per week coverage as follows:
 - 1. A ten (10) hour shift, six (6) days per week.
 - 2. Two (2) ten (10) hour shifts, one (1) day per week.

- B. These schedules may be modified as needed by assigned Deputy Sheriffs after consultation with Sheriff Command structure and the Village Law Enforcement Advocate. Such modifications will not violate any union contracts or hours of coverage provided in this Agreement.
- C. In the event the Deputy Sheriffs assigned to the Village are reassigned by the Sheriff to work detail outside the Village for non-emergency issues, and have not been replaced by another Deputy Sheriff, the Village shall be credited with compensatory time, which shall be used as mutually agreed upon by the Sheriff and the Village. The Village Clerk will be notified of all reassignments and the amount of hours taken from the Village.

III. Cooperation and Enforcement of Village Ordinances. The Sheriff shall cooperate with Village officials in the enforcement of Village ordinances. The Village shall be responsible for the prosecution and the legal costs required in these matters and shall provide the necessary prosecutorial support to adjudicate such cases.

IV. Equipment to be Provided by the County. The County shall provide and maintain at its expense the motor vehicles to be used for police protection and patrol and any and all uniforms, weapons, insignia and general police equipment to be used by any Deputy Sheriffs assigned to duty in the Village.

V. Office and Garage Space. The Village shall provide and maintain office and garage space to be utilized by Deputy Sheriffs assigned to the Village.

VI. Telephones. If the County and the Village mutually agree, the Village shall maintain telephone service to be utilized by Deputy Sheriffs assigned to the Village. The Village shall provide monthly logs, with the cost of the telephone service to the County for credit towards the sum to be paid to the County under this Agreement.

VII. Gasoline. If the County and the Village mutually agree the Deputy Sheriffs assigned to the Village may utilize gasoline pumps owned by the Village to fuel their squad cars. If this option is used, the Village shall provide monthly logs with price and quantity information to the County for credit toward the sum to be paid the County under this Agreement.

VIII. Insurance. The County shall provide insurance for the motor vehicle(s) used in the performance of the services described in the Section II of this Agreement, as well as the liability and workers' compensation insurance coverage for any Deputy Sheriffs assigned to duty in the Village. "Insurance", insofar as vehicles and Deputy Sheriffs are concerned, means the coverage provided by the County as of January 1, 2024. If such coverage is discontinued for any reason, the County shall notify the Village immediately.

IX. Compensation. It is expressly understood and agreed that the Village shall pay the County for the services which it receives from Deputy Sheriffs under this Agreement as follows:

- A. The sum of THREE HUNDRED FORTY-THREE THOUSAND THREE HUNDRED NINETY-FIVE AND NO/100 DOLLARS (\$343,395.00) for the period covering January 1, 2024 through December 31, 2024.
- B. The sum of THREE HUNDRED SIXTY THOUSAND FIVE HUNDRED SIXTY-FIVE AND NO/100 DOLLARS (\$360,565.00) for the period covering January 1, 2025 through December 31, 2025.
- C. The sum of THREE HUNDRED SEVENTY-EIGHT THOUSAND FIVE HUNDRED NINETY-THREE AND NO/100 DOLLARS (\$378,593.00) for the period covering January 1, 2026 through December 31, 2026.

The sum due the County during each twelve (12) month period covered by this Agreement shall be paid in equal quarterly installments, due at the end of each quarter, with payments to be made by no later than the 15th day of the month following the end of a quarter. All payments shall be made payable to the COUNTY OF INGHAM and submitted to the Ingham County Controller's Office.

X. **Reports.** At the specific written request of the Village, the Sheriff shall provide to the Village a report, but only as it relates to law enforcement services provided in accordance with this Agreement. The report shall include time out of the Village for: the Village, the County, Emergent Needs and Special Police Needs. For definitions of emergent needs and special police needs, see the Ingham County Mutual Aid Police Assistance Agreement.

XI. **Status of Sheriff Deputies Assigned to the Village.** The Deputy Sheriffs assigned to the Village are and shall remain employees of the Sheriff and the County and shall be under the Sheriff's supervision, direction, and control.

XII. **Sheriff Responsible for Management.** The Sheriff shall be solely responsible for the management of the Deputy Sheriffs assigned to the Village under this Agreement. Management shall be construed to include, but not be limited to, determining priority of investigation; determining what constitutes a life threatening emergency; determining the specific personnel to be assigned to the Village; determining job duties and assignments; and determining the adequacy of motor vehicles deployed. The Sheriff will consult with the Village on routine or special matters as deemed appropriate.

XIII. **Removal of Deputy Sheriffs for Emergencies.** The Sheriff reserves the right to remove any Deputy who is otherwise assigned to the Village for emergencies that might exist outside the Village.

XIV. **Nondiscrimination.** In carrying out the terms of this Agreement, the parties hereto shall adhere to all applicable Federal, State and local laws, regulations and policies prohibiting discrimination. The parties hereto, as required by law and/or policies of either the County or the Village shall not discriminate against persons to receive services under this Agreement or against an employee or applicant for employment with respect to hire, tenure, terms, conditions or privileges of employment, or a matter directly or indirectly related to employment, because of race,

color, religion, national origin, age, sex, sexual orientation, gender identity or expression, disability or genetic information that is unrelated to the individual's ability to perform the duties of a particular job or position, height, weight, marital status or political affiliation or beliefs. Breach of this covenant shall be regarded as a material breach of this Agreement.

XV. Agreement Does Not Affect Collective Bargaining Agreements. It is expressly understood and agreed by the parties hereto that the requirements of this Agreement shall not be construed as in any way affecting the collective bargaining agreement covering the Sheriff Deputies assigned to the Village under this Agreement including, but not limited to, the adding of provisions thereto or subtracting provisions therefrom.

XVI. Communication. It is agreed to by the parties that prompt and timely resolution of issues and/or concerns is vital to the success of this Agreement. Therefore, the parties agree that the following steps will be utilized:

- A. The Law Enforcement Advocate from the Village Council will meet regularly with the supervisor of the Deputies assigned to the Village for purposes of resolving issues and/or concerns.
- B. If issues and/or concerns cannot be resolved in the above mentioned meetings between the Village Law Enforcement Advocate and the Deputies' supervisor, in a timely manner, then the Law Enforcement Advocate will meet with the Undersheriff to pursue a resolution.

XVII. Waivers. No failure or delay on the part of any of the parties to this Agreement in exercising any right, power or privilege hereunder shall operate as a waiver thereof nor shall a single or partial exercise of any right, power or privilege preclude any other or further exercise of any other right, power or privilege.

XVIII. Modification of Agreement. Modifications, amendments or waivers of any provision of this Agreement may be made only by the written mutual consent of the parties hereto.

XIX. Assignment or Subcontracting. The parties to this Agreement may not assign, subcontract or otherwise transfer their duties and/or obligations under this Agreement.

XX. Non-Third Party Beneficiary Contract. This Agreement is not intended to be a third party beneficiary contract and confers no rights on anyone other than the parties hereto.

XXI. Purpose of Section Titles. The titles of the sections set forth in this Agreement are inserted for the convenience of reference only and shall be disregarded when construing or interpreting any of the provisions of this Agreement.

XXII. Complete Agreement. This Agreement contains all the terms and conditions agreed upon by the parties hereto, and no other agreements, oral or otherwise, regarding the subject matter of this Agreement or any part thereof shall have any validity or bind any of the parties hereto and any prior agreements shall be null and void.

XXIII. Invalid Provisions. If any clause or provision of this Agreement is rendered invalid or unenforceable because of any State or Federal statute or regulation or ruling by any tribunal of competent jurisdiction, that clause or provision shall be null and void, and any such invalidity or unenforceability shall not affect the validity or enforceability of the remainder of this Agreement. It shall be considered to be deleted and the remainder of this Agreement shall not be affected thereby. Where the deletion of the invalid provision would result in the illegality and/or unenforceability of this Agreement, this Agreement shall be considered to have terminated as of the date in which the provision was rendered invalid or unenforceable.

XXIV. Certification of Authority to Sign Agreement. The people signing on behalf of the parties hereto certify by their signatures that they are duly authorized to sign this Agreement on behalf of said parties and that this Agreement has been authorized by said parties.
